

TERMS AND CONDITIONS OF ACCESS AND USE

You hereby irrevocably waive all objections which you may now or hereafter have to the exercise of personal and subject matter jurisdiction by the federal or state courts in Liberty Township, Ohio and to the laying of venue of any such suit, action, or proceeding brought in any such federal or state court in Liberty Township, Ohio.

5. Headings

The captions and headings of this Agreement are included for ease of reference only and shall be disregarded in interpreting or construing this Agreement.

6. Entire Agreement

This Agreement constitutes the complete and exclusive statement of the agreement between the parties and supersedes all prior or contemporaneous communications, representations, statements and understandings, whether oral or written, between the parties.

PASSWORD PROTECTED SITES
